WHEREAS, Councilmember Dan Kalb, an appointed Delegate to the League of California Cities, is planning on traveling to Long Beach, CA on October 16, 2019 to attend the 2019 Annual Conference on October 16-18, 2019; and

WHEREAS, City Council Resolution No. 82800 C.M.S. approved by the Council on June 1, 2010 requires that, when Councilmembers seek Council approval for using City funds for travel, their agenda materials shall indicate whether travel involves airline transportation and lodging and shall provide an estimate of the cost of airline, lodging, per diem and conference fees and the source of City funding that will be used to cover the travel costs; and
