RESOLUTION AUTHORIZING AWARD OF A CONTRACT TO MOSTO CONSTRUCTION FOR THE STORM DRAINAGE IMPROVEMENT ON PARKER AVENUE BETWEEN HILLMONT DRIVE AND OUTLOOK AVENUE (PROJECT NO. C141910) FOR THE AMOUNT OF ONE HUNDRED TWENTY-EIGHT THOUSAND SEVEN HUNDRED THIRTY-THREE DOLLARS (128,733)

WHEREAS, on June 2, 2003 two bids were received by the Office of the City Clerk of the City of Oakland for the Storm Drainage Improvement on Parker Avenue Between Hillmont Drive and Outlook Avenue (Project No. C141910); and

WHEREAS, Mosto Construction, with 5% bid discount as a certified business bidding as a prime, is the lowest responsible bidder for the project; and

WHEREAS, there are sufficient funds in Fund 3100, Project C141910, for the contract work; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy or better performance; and

WHEREAS, Mosto Construction complies with all LBE/SLBE goals; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now, therefore, be it

RESOLVED: That the contract for the Storm Drainage Improvement on Parker Avenue Between Hillmont Drive and Outlook Avenue is hereby awarded to Mosto Construction in accordance with the terms of its bid therefore, dated June 2, 2003, for the amount of one hundred twenty-eight thousand seven hundred thirty-three dollars (128,733); and be it

FURTHER RESOLVED: That the plans and specifications prepared by the Director of Public Works for this project are hereby approved; and be it

FURTHER RESOLVED: That the amount of the bond for faithful performance, \$64,366.50 and the amount for a bond to guarantee payment of all claims for labor and materials furnished and for the amount due under the Unemployment Insurance Act, \$128,733 with respect to such work are hereby approved; and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to enter into a contract with Mosto Construction on behalf of the City of Oakland and to execute any amendments or modifications to said agreement within the limitations of the project specifications; and be it

FURTHER RESOLVED: That all other bids are hereby rejected; and be it

FURTHER RESOLVED: That the contract shall be reviewed and approved by the City Attorney and placed on file in the Office of the City Clerk; and be it

FURTHER RESOLVED: That the approval of this Resolution requires a two-thirds vote of the Council members.
