Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing the City Attorney to compromise and settle the above-entitled action. Due to the risk of an adverse jury verdict under the circumstances settlement is recommended in the sum of Five Hundred Thousand Dollars and No Cents (\$500,000.00) payable to Plaintiff Douglas Bushey and Claude A. Wyle, his attorney.

This action arises from an accident on August 24, 2006 in which Mr. Bushey was thrown to the pavement after his bicycle struck a pothole as he was riding through the intersection of Piedmont Avenue and MacArthur Boulevard. Mr. Bushey claims that the street where the accident occurred was rutted and in a dangerous condition. Mr. Bushey sustained serious injuries requiring extensive medical treatment as a result of this accident. This matter was approved in closed session on May 4, 2010.
