**WHEREAS**, Mr. Chambers has spent many week nights and Saturdays at community meetings to the detriment of his golf game and other hobbies,

**WHEREAS**, Mr. Chambers has been the cause of grief, as he would explain to the City Councilmembers why their streets were not going to be repaved,
