INTRODUCED BY MAYOR BARBARA LEE AND COUNCILMEMBER UNGER

RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF DANFORTH DOUGHERTY TO THE BUDGET ADVISORY COMMISSION

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No. 13337 C.M.S., adopted November 3, 2015, creates the Budget Advisory Commission to advise the Mayor and City Council on topics deemed important to the fiscal health of the City, encourage public participation and input into fiscal decision making, and improve the transparency and accountability of City fiscal information and decision making; and

WHEREAS, the Budget Advisory Commission shall be composed of 15 members appointed by the Mayor and confirmed by the Council in accordance with Section 601 of the City Charter; and

WHEREAS, members of the Budget Advisory Commission shall serve no more than two consecutive three-year terms plus any initial term of less than two years; and

WHEREAS, three members are selected by the Mayor, two members are recommended by the Chairperson of the Finance and Management Committee, one member is recommended by each Councilmember, one member is recommended by the City Auditor, and one member is recommended by the Chairperson of the Community and Economic Development Committee; and

WHEREAS, Councilmember Zachary Unger has recommended the appointment of Danforth Dougherty to the Budget Advisory Commission; now, therefore, be it

RESOLVED: That pursuant to Section 601 of the City Charter, the City Council hereby confirms the Mayor's appointment of:

Danforth Dougherty to the Budget Advisory Commission to serve the remainder of the three-year term as the District 1 representative, beginning October 1, 2025 and ending September 30, 2028, filling the seat vacated by Brenda Roberts.


