RESOLUTION AUTHORIZING A GRANT OF \$10,000 FROM COUNCILMEMBER JEAN QUAN'S PAY-GO FUNDS TO ARTISTS DEBORAH KOPPMAN AND AMANDA LOCKWOOD FOR A MURAL TO BE INSTALLED ON FARMER JOE'S MARKET IN THE DIMOND DISTRICT

WHEREAS, on July 17, 2007 the City Council adopted Resolution No. 80777 C.M.S. authorizing individual Councilmembers to designate pay-go funds for City of Oakland (i.e., municipal) infrastructure, furniture or equipment expenditures, or for grants to other government agencies within Oakland for their infrastructure, furniture or equipment expenditures; and

WHEREAS, City Council approval is required to designate pay-go funds for other uses; and

WHEREAS, Councilmember Jean Quan wishes to grant \$10,000 of her pay-go funds to artists Deborah Koppman and Amanda Lockwood for a large mural depicting Dimond District history on the wall of Farmer Joe's Market located at 3426 Fruitvale Avenue in Oakland, a privately-owned business property; and

WHEREAS Koppman and Lockwood are well known Dimond artists, working as artists in residence at Sequoia Elementary School, and their project has been heralded by the Dimond Community and the City's Public Art Commission; and

WHEREAS, owners of Farmer Joe's Market, who are committed Oakland business persons and have established two grocery stores in Oakland, wish to have the Dimond District mural installed on their grocery store to enhance and beautify the Dimond District; and

WHEREAS, Koppman and Lockwood will obtain all necessary approvals, rights of entry, licenses or other property access rights required by the City and by owners of Farmer Joe's Market to install and maintain the mural; and

WHEREAS, in conformance with City requirements, Koppman and Lockwood will provide documentation for the use of the Councilmember's pay-go funds; and

RESOLVED: That the City Council authorizes a grant of \$10,000 from Councilmember Jean Quan's pay-go account to Koppman and Lockwood for the installation of a mural depicting history of the Dimond District on the Farmer Joe's Market at 3426 Fruitvale Avenue in Oakland; and be it

FURTHER RESOLVED: That the City Administrator shall enter into a pay-go grant agreement with Koppman and Lockwood for the above purposes; and be it

FURTHER RESOLVED: That as a condition of the grant Koppman and Lockwood shall be required to agree to assume responsibility for and to obtain all necessary approvals, rights of entry, licenses or other, property access rights required by the City and by owners of Farmer Joe's Market to install and maintain the mural; and

FURTHER RESOLVED: The agreement will reviewed and approved by the City Attorney for form and legality and placed on file in the Office of the City Clerk.
