

## OAKLAND CITY COUNCIL

RESOLUTION NO. 88817 C.M.S.

## **RESOLUTION TO:**

- 1) ACCEPT AND APPROPRIATE FUNDS FROM THE CITY OF EMERYVILLE IN AN AMOUNT NOT TO EXCEED \$55,000 TO SUPPORT EMERGENCY SHELTER OPERATIONS FOR JULY 1, 2021 THROUGH JUNE 30, 2022, AND AUTHORIZE AN AGREEMENT FOR RECEIPT OF SAID FUNDS; AND
- 2) AWARD GRANT AGREEMENTS TO: 1) CORNERSTONE COMMUNITY DEVELOPMET CORPORATION, DBA BUILDING FUTURES FOR WOMEN AND CHILDREN IN AN AMOUNT NOT TO EXCEED \$25,000 TO OPERATE THE FAMILY FRONT DOOR; AND 2) THE SOCIETY OF SAINT VINCENT DE PAUL IN AN AMOUNT NOT TO EXCEED \$30,000 TO PROVIDE EMERGENCY SHELTER FOR SINGLE ADULTS; AND
- 3) ACCEPT AND APPROPRIATE ADDITIONAL FUNDS THAT BECOME AVAILABLE FROM THE CITY OF EMERYVILLE, FOR THE SAME PURPOSES, WITHIN THE GRANT TERM OF JULY 1, 2021 THROUGH JUNE 30, 2022 AND AUTHORIZE THE CITY ADMINISTRATOR TO AMEND THE GRANT AGREEMENTS TO ADJUST THE GRANT AMOUNTS

**WHEREAS**, approximately 4,071 persons experience homelessness in the City of Oakland on a given night, including 3,210 unsheltered persons; and

WHEREAS, approximately 1,537 adults and children in 499 families experience homelessness in the City of Oakland over the course of a year; and

WHEREAS on October 3, 2017, the City Council adopted Resolution No. 86919 C.MS., authorizing, among other things, acceptance of funding from the City of Emeryville, by and through an authorized grant agreement and amendment for the provision of the Family Front Door services for Fiscal Years (FY) 2017-18, 2018-19, and 2019-20; and

**WHEREAS**, on June 16, 2020, the City Council adopted Resolution No. 88165 C.M.S. to extend the Family Front Door grant term to FY 2020-21; and

WHEREAS, the funding was used to support a regional coordinated entry system for families experiencing homelessness to connect them with the resources available in the community; and

WHEREAS, staff wish to accept additional funding from the City of Emeryville, by and through a grant agreement to continue providing family homelessness services for FY 2021-22; and

WHEREAS, the City desires to enter into a grant agreement with Saint Vincent de Paul ("SVDP") in an amount not to exceed \$30,000 to support the operations of SVDP shelter; and

WHEREAS, the City desires to enter a grant agreement with Building Futures for Women and Children ("BFWC") for an amount up to \$25,000 for the operation of the family homelessness coordinated entry system; now, therefore be it

**RESOLVED:** That the City Council hereby accepts and appropriates funds from the City of Emeryville in an amount not to exceed \$55,000 to continue supporting emergency shelter operations for FY 2021-22, and authorizes an agreement with the City of Emeryville to accept said funds; and be it

**FURTHER RESOLVED:** That said funding will be appropriated to Fund 2994, Project 1003911, Org 78411, Expense 54912, Task 1-DEFAULT, Award 23297; and be it

**FURTHER RESOLVED:** That the City Council hereby awards a grant agreement to SVDP in an amount not to exceed \$30,000 to continue providing emergency shelter services for single adults for FY 2021-22; and be it

**FURTHER RESOLVED:** That the City Council hereby awards a grant agreement to BFWC in an amount not to exceed \$25,000 to continue providing regional coordinated entry services for families experiencing homelessness for FY 2021-22; and be it

**FURTHER RESOLVED:** That the City Administrator is hereby authorized, without returning to Council, to accept and appropriate additional funds from the City of Emeryville within FY 2021-22 for the same purpose, and to amend the above-referenced grant agreements with BFWC and SVDP to adjust the grant amount, so long as the total grant amount does not exceed the total amount of funds accepted from City of Emeryville and appropriated.
