

INTRODUCED BY VICE MAYOR LARRY E. REID

**RESOLUTION WAIVING THE BIDDING REQUIREMENTS FOR TRANSPORTATION SERVICES AND AUTHORIZING USE OF VICE MAYOR LARRY E. REID'S PAY-GO FUNDS TO PAY FOR SMALL BUSINESS SYMPOSIUM EXPENSES AS FOLLOWS: \$21,266.40 FOR FACILITY RENTAL AT THE MARRIOTT OAKLAND CITY CENTER, \$5,256.00 FOR SYMPOSIUM SERVICES BY ROSSI PRODUCTIONS AND \$575.00 FOR TRANSPORTATION SERVICES BY MACARTHUR BUS LINE**

**WHEREAS**, Vice Mayor Larry E. Reid wishes to use a portion of his Pay-Go funds to be used for expenses for the Small Business Symposium, for public workshops on the start up of a small business, how to operate the business and business growth; and

**WHEREAS**, Vice Mayor Larry E. Reid requests authorization to use Pay-Go funds for the symposium as follows: \$21,266.40 for facility rental at the Marriott Oakland City Center, \$5,256.00 for symposium services by Rossi Productions and \$575.00 for transportation services by MacArthur Bus Line, and

**WHEREAS**, staff did not solicit bids for transportation services as it would have been administratively burdensome for a small expenditure of \$575.00; now, therefore, be it

**RESOLVED:** That the City Council authorizes the use of Vice Mayor Larry E. Reid's Pay-Go funds for Small Business Symposium expenses; and, be it

**FURTHER RESOLVED:** That, pursuant to Oakland Municipal Code Section 2.04.050.1.5, the City Council finds and determines that it is in the City's best interests to waive the competitive bidding requirement for Symposium transportation.


