President De La Fuente and Members of the City Council:

Pursuant to §401 of the Charter, and the action of the Council at its December 18, 2007, closed session, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action in the total sum of Twenty-Five Thousand Dollars (\$ 25,000.00), made payable to the Millsmont Homeowners Association (MHA) and its attorney, Natural Heritage Institute, for attorney's fees and; assent to a Consent Decree under which DeSilva Gates Construction, L.P. will fund a feasibility study for restoration of Chimes Creek and the City and MHA will thereafter cooperatively seek funding for the creek restoration project.

This settlement is recommended as a compromise of this matter and to avoid an adverse jury verdict and possible exposure to civil penalties and larger attorney's fees.
