RESOLUTION AUTHORIZING A CONTRACT WITH CCS PLANNING AND ENGINEERING / J. MULLER INTERNATIONAL, JOINT VENTURE, TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR THE LAKE MERRITT CHANNEL BRIDGE REPLACEMENT PROJECT IN AN AMOUNT NOT TO EXCEED \$1,100,000 AND APPROPRIATING \$1,048,000 IN FEDERAL HIGHWAY FUNDS

WHEREAS, the Lake Merritt Channel Bridge has been identified by the California Department of Transportation (Caltrans), the statewide agency responsible for bridge safety, as being in need of replacement; and

WHEREAS, the Lake Merritt Channel Bridge will be reconstructed to comply with current seismic safety guidelines; and

WHEREAS, the California Department of Transportation (Caltrans) will fund the project from a combination of state and federal bridge programs; and

WHEREAS, the required local share of \$52,000 is available from Measure 'B' contingency funds appropriated by Council on December 12, 2000; and

WHEREAS, the project consists of the demolition and replacement of the existing bridge and complete reconstruction of both approaches, bridge abutments, pavement, bike facilities, concrete sidewalk, curb and gutter, street lighting, and minor landscaping; and

WHEREAS, CCS Planning and Engineering / J. Muller International, Joint Venture, has submitted a proposal to provide full design services, including preparing plans, specifications, and cost estimates, holding public meetings, preparing environmental studies necessary to fulfill California Environmental Quality Act (CEQA) and National Energy Policy Act (NEPA) requirements, and securing permits; and

WHEREAS, CCS Planning and Engineering / J. Muller International was chosen through the City's Request for Proposal process as the top rated firm to provide the services; and

WHEREAS, the City Council finds that this contract is for services of a professional nature; and

WHEREAS, the City Council finds that services under contract will be temporary; and

WHEREAS, Council finds that this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

RESOLVED: That the City Manager is hereby authorized to enter into an Agreement with CCS Planning and Engineering / J. Muller International, Joint Venture, to provide professional civil engineering and related design services for the Lake Merritt Channel Bridge Replacement Project in an amount for basic services not to exceed One Million Fifty Seven Thousand Three Hundred Thirty Seven Dollars (\$1,057,337); and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to exceed the amount for basic services for unforeseen contingencies in an amount not to exceed Forty Two Thousand Six Hundred Sixty Three Dollars (\$42,663); and be it

FURTHER RESOLVED: That the total amount of the Agreement, including an amount for unforeseen contingencies is for a total amount not to exceed One Million One Hundred Thousand Dollars (\$1,100,000); and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to appropriate \$1,048,000 in federal highway funds (fund 2116); and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to approve any subsequent amendments to or extensions of said agreement except those involving compensation or the allocation of additional funds provided that such amendments or extensions shall be filed with the City Clerks Office: and be it

FURTHER RESOLVED: That a copy of the agreement will be on file in the City Clerks Office and will be approved for form and legality by the Office of the City Attorney.


