RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE PROPERTY DAMAGE CLAIM OF SCOTTSDALE INSURANCE COMPANY AS SUBROGEE OF PAMER TOWN CAR SERVICE, IN THE AMOUNT OF \$12,831.38, AS A RESULT OF PROPERTY DAMAGE SUSTAINED IN A TRAFFIC COLLISION WITH A CITY VEHICLE ON JUNE 23, 2011. WHEREAS, on June 23, 2011, the City employee collided with the claimant vehicle in the intersection of 11th and Clay Streets; and

WHEREAS, the City of Oakland has determined that settlement in this amount, without an admission of liability, is in the best interest of the City and now,
