**RESOLUTION AUTHORIZING COUNCILMEMBER DAN KALB TO TRAVEL TO SACRAMENTO, CALIFORNIA TO ATTEND THE LEAGUE OF CALIFORNIA CITIES' ANNUAL CONFERENCE ON SEPTEMBER 13-15, 2017, AND BE REIMBURSED FOR NECESSARY EXPENSES**

**WHEREAS**, Councilmember Dan Kalb, an appointed Delegate to the League of California Cities, is planning on attending the 2017 League of California Cities' Annual Conference and Expo in Sacramento, CA from September 13 through September 15, 2017; and

**WHEREAS**, City Council Resolution No. 82800 C.M.S. approved by the Council on June 1, 2010 requires that, when Councilmembers seek Council approval for using City funds for travel, their agenda materials shall indicate whether travel involves airline transportation and lodging and shall provide an estimate of the cost of airline, lodging, per diem and conference fees and the source of City funding that will be used to cover the travel costs; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost for Councilmember Kalb is up to \$110 for mileage reimbursement and parking, \$290 for two nights of lodging, up to \$118 for three days of per diem, and \$525.00 for conference attendance fees; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be the City Council Contingency Project funds; and

**WHEREAS**, Councilmember Dan Kalb seeks City Council approval of the aforementioned estimated costs to travel to Sacramento, CA to attend the Fall 2017 League of California Cities convention; now, therefore, be it

**RESOLVED:** That all expenses incurred for said travel are hereby authorized.
