A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, ON BEHALF OF THE CITY OF OAKLAND, TO APPROPRIATE TO THE OFFICE OF THE CITY AUDITOR \$250,000 IN FISCAL YEAR 2008-2009 AND \$250,000 IN FISCAL YEAR 2009-2010 IN GENERAL PURPOSE FUNDS FOR THE PURPOSE OF FUNDING ADMINISTRATION OF THE CITY AUDITOR'S WHISTLEBLOWER PROGRAM

**Whereas**, the City Auditor maintains a Whistleblower Program for the purpose of receiving individual complaints concerning the quality and delivery of government services, wasteful and inefficient City government practices, misuse of City funds, and improper activities by City officers and employees; and

**Whereas**, the City of Oakland has an interest in protecting the integrity of the City Auditor's Whistleblower Program; and

**Whereas**, the Office of the City Auditor presently lacks sufficient resources to administer the Whistleblower Program; and

**Whereas,** the Office of the City Auditor desires additional funding in the amount of \$250,000 in fiscal year 2008-2009 and \$250,000 in fiscal year 2009-2010 to establish a whistleblower hotline, investigate whistleblower tips and to process complaints of retaliation; now, therefore, be it

**RESOLVED:** that the City Administrator, on behalf of the City of Oakland, is hereby authorized to appropriate to the Office of the City Auditor \$250,000 in fiscal year 2008-2009 and \$250,000 in fiscal year 2009-2010 in general purpose funds for the purpose of funding the administration of the City Auditor's Whistleblower Program.
