INTRODUCED BY COUNCILMEMBER REBECCA KAPLAN

RESOLUTION RE-ALLOCATING THE GRANT OF \$500.00 FROM COUNCILMEMBER KAPLAN'S PAY-GO FUNDS FROM GOOD HOPE BAPTIST CHURCH TO GALATIANS BAPTIST CHURCH'S YOUTH GROUP FOR TRAVEL AND MEAL EXPENSES TO DISNEYLAND, CA.

WHEREAS, on July 17, 2007, the City Council revised the Pay-Go procedures to limit Pay-Go uses to City of Oakland infrastructure, furniture or equipment expenditures, or to grants to other government agencies for infrastructure, furniture or equipment expenditures; and

WHEREAS, any expenditures for purposes other than City or other governmental infrastructure, furniture, or equipment require council approval; and

WHEREAS, Councilmember Rebecca Kaplan wishes to grant a portion of her Pay-Go funds to the Galatians Baptist Church's Youth Group for travel and meal expenses to Disneyland, CA; and

WHEREAS, in conformance with City requirements, the Galatians Baptist Church's Youth Group will provide documentation for the use of the Councilmember's Pay-Go funds; now, therefore, be it

RESOLVED, that the City Council authorizes the grant of \$500.00 from Councilmember Rebecca Kaplan's Pay-Go funds to the Galatians Baptist Church's Youth Group for travel to Disneyland, CA; and, be it

FURTHER RESOLVED, that the City Administrator is authorized to execute an appropriate grant agreement with the Galatians Baptist Church's Youth Group for the above purpose, subject to approval as to form and legality by the City Attorney.
