**WHEREAS**, the Fire Department's Office of Emergency Services proposes to receive supplemental Federal Fiscal Year 2011 Urban Areas Security Initiative grant (Federal Fiscal Year 2011 UASI grant) funding from San Mateo County for services provided in connection with the Northern California Regional Intelligence Center (NCRIC) Operations, which is a federal, state and local public safety effort that involves the intake, analysis, fusion, synthesis, and appropriate dissemination of criminal and homeland security intelligence in the greater San Francisco Bay Area and the northern coastal counties of California; and
