**WHEREAS**, The City will require Oakland Coliseum Joint Venture to provide documentation for use of the Councilmember's priority project funds; now, therefore, be it

**RESOLVED:** That the City Council authorizes the grant of \$5,408.01 from Councilmember Larry E. Reid's priority project funds to Oakland Coliseum Joint Venture for the Ninth Annual Oakland/San Leandro Job Fair; and, be it

**FURTHER RESOLVED**: That the City Administrator is authorized to execute an appropriate grant agreement with the Oakland Coliseum Joint Venture with the purposes of the grant, subject to approval as to form and legality by the City Attorney.
