ORDINANCE: (1) AMENDING OAKLAND MUNICIPAL CODE 10.48.010 TO INCREASE FINES FOR PARKING CITATIONS CONSISTENT WITH PREVIOUS CITY COUNCIL DIRECTION; (2) ADOPTING A FINE OF \$40 FOR CALIFORNIA VEHICLE CODE 22500(N) IN SUPPORT OF DAYLIGHTING; (3) AMENDING OAKLAND MUNICIPAL CODE 10.48.010 CONSISTENT WITH OAKLAND ORDINANCE 12607; (4) AMENDING OAKLAND MUNICIPAL CODE 10.48.010 TO RESOLVE INCONSISTENCIES BETWEEN OAKLAND MUNICIPAL CODE AND THE CALIFORNIA VEHICLE CODE AND (5) ADOPTING APPROPRIATE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) FINDINGS

WHEREAS, the City of Oakland (City) periodically amends and updates its parking fines to account for the various cost increases relating to municipal programs, services and activities; and

WHEREAS, the City recognizes that the parking system should be actively managed to maximize efficient use of a public resource, according to Oakland's Parking Principles (Resolution No. 84664 C.M.S.); and

WHEREAS, the City of Oakland Department of Transportation (OakDOT) is tasked with managing public parking to balance the diverse needs of Oakland's visitors, merchants, commuters and residents and with improving transportation choices and minimizing parking demand, congestion, and pollution (OakDOT Strategic Plan); and

**WHEREAS**, the City Council approved budget for Fiscal Years 2023-2025 included two year-over-year increases of five percent for parking fines as an inflation adjustment (Resolution 89804 C.M.S.); and

WHEREAS, Assembly Bill (AB) 413 established new rules for "daylighting" intersections to increase driver sight distances and improve pedestrian visibility. California Vehicle Code (CVC) § 22500(n) implements AB 413 by making it illegal to park, stop or stand within twenty feet on the approach side of a marked or unmarked crosswalk; and

- WHEREAS, establishing a fine of \$40 for violation of CVC § 22500(n) will allow the City to enforce this CVC section, thereby increasing pedestrian safety; and
- WHEREAS, a fine in the amount of \$40.00 for violation of CVC § 22500(n) prohibiting parking within 20 feet of a crosswalk on the approach side is consistent with the enforcement authority granted by AB 413 and does not require signage or curb markings; and
- WHEREAS, CVC Division 18, Chapter 1 establishes penalties for various vehicle code violations, including minimum and maximum fine amounts; and
- WHEREAS, in preparing this report, staff referenced CVC Division 18, Chapter 1 to ensure all proposed fines fall within the minimum and maximum amounts set forth therein. The fine for violating CVC § 22511 was found to be below the minimum required and is therefore proposed to be increased from \$80 to \$100; and
- **WHEREAS**, the proposed fees and charges that are imposed for a specific government service, benefit or product, or regulatory program are provided directly to the payer and not provided to those not charged, and do not exceed the reasonable costs to the City of providing the service, benefit or product, or regulatory program; and
- **WHEREAS**, Oakland Municipal Code (OMC) § 10.48.010 included City Traffic Code Section 10.08.150 and 10.16.070, both were formerly repealed by Ordinance 12607 and therefore removed from § 10.48.010; and
- WHEREAS, OMC § 10.48.010 included City Traffic Code Section 10.28.290, the correct City Traffic Code Section is 10.28.280 and therefore § 10.48.010 was amended to accurately reflect the correct City Traffic Code; and
- WHEREAS, OMC § 10.48.010 included State Vehicle Code Section 22500.I, the correct State Vehicle Code Section is 22500(i) and therefore § 10.48.010 was amended to accurately reflect the correct State Vehicle Code Section; and
- WHEREAS, OMC § 10.48.010 included State Vehicle Code Section 22500.L, the correct State Vehicle Code Section is 22500(l) and therefore § 10.48.010 was amended to accurately reflect the correct State Vehicle Code Section; and
- WHEREAS, OMC § 10.48.010 included State Vehicle Code Section 22507.8A, the correct State Vehicle Code Section is 22507.8(a) and therefore § 10.48.010 was amended to accurately reflect the correct State Vehicle Code Section; and
- WHEREAS, OMC § 10.48.010 included State Vehicle Code Section 22507.8B, the correct State Vehicle Code Section is 22507.8(b) and therefore § 10.48.010 was amended to accurately reflect the correct State Vehicle Code Section; and

WHEREAS, OMC § 10.48.010 included State Vehicle Code Section 22507.8C, the correct State Vehicle Code Section is 22507.8(c) and therefore § 10.48.010 was amended to accurately reflect the correct State Vehicle Code Section; and

WHEREAS, OMC § 10.48.010 included State Vehicle Code Section 22520, Assembly Bill 1561 in 1997 repealed State Vehicle Code Section 22520 and replaced it with State Vehicle Code Section 21718 and therefore § 10.48.010 was amended to accurately reflect the correct State Vehicle Code Section; and

WHEREAS, these actions are exempt from the California Environmental Quality Act (CEQA) pursuant to Public Resources Code Section 21080(b)(8) and CEQA Guidelines Section 15273 (Rates, Tolls, Fares, and Charges) because CEQA does not apply to the establishment, modification, structuring, restructuring, or approval of rates, tolls, fares, or other charges by public agencies which the public agency finds are for the purpose of meeting operating expenses or obtaining funds for capital projects, necessary to maintain service within existing service areas. Additionally, these actions are not a project which has the potential for causing a significant effect on the environment, pursuant to Section 15061(b)(3) of the CEQA Guidelines because it does not have a potential for resulting in either a direct physical change in the environment.

# NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

The City Council hereby declares that it would have passed this Ordinance and each

section, subsection, clause or phrase thereof irrespective of the fact that one or more other sections, subsections, clauses or phrases may be declared invalid or unconstitutional.

**SECTION 4.** Effective Date. This ordinance shall become effective immediately on final adoption if it receives six or more affirmative votes; otherwise, it shall become effective upon the seventh day after final adoption.

This Ordinance authorizes the City Administrator to amend the Oakland Municipal Code to increase parking fines by approximately ten percent to account for inflation. It also adds a new \$40 citation for violations of California Vehicle Code section 22500(N), which prohibits parking within 20 feet of an intersection. In addition, this Ordinance makes multiple changes to the parking citations section of the Municipal Code to ensure consistency with previously adopted ordinances and the California Vehicle Code.
