## INTRODUCED BY COUNCIL PRESIDENT DE LA FUENTE

RESOLUTION AUTHORIZING A GRANT FROM COUNCILMEMBER DE LA FUENTE'S PRIORITY PROJECT FUNDS TO THE MUSEUM OF CHILDREN'S ART IN THE AMOUNT OF \$18,900 TO FUND INTENSIVE ARTS EDUCATION PROGRAMS SERVING 1,132 CHILDREN IN OAKLAND'S FRUITVALE NEIGHBORHOOD

WHEREAS, On June 8, 2006 the City Council did amend the 2005-2007 Policy Budget for the City of Oakland to include \$250,000 a piece for the Mayor and each councilmember to use as priority funds for projects in the City of Oakland or in Councilmember's districts subject to City Council approval; and

WHEREAS, Council President De La Fuente wishes to grant a portion of his priority project funds to the Museum of Children's Art in the amount of \$18,900 to fund intensive arts education programs serving 1,132 children in Oakland's Fruitvale neighborhood, including:

- Arts instruction for students and teacher professional development at ASCEND School, Bridges School, International Community School, Manzanita SEED and Garfield Elementary, designed to enhance student learning in Language Arts, math, science and social science;
- Intensive arts-based residencies geared at building young children's school readiness skills at De Colores and International Child Development Centers;
- The Sandboxes to Empowerment Program, consisting of twice-weekly parentchild playgroups at Carmen Flores Recreation Center. This program is offered in collaboration with the Office of Parks and Recreation and Lotus Bloom Child and Family Resource Center. The playgroups provide ongoing opportunities for parents and children to engage in art, movement, music and literacy-based activities that support early learning and developmental growth, as well as healthy attachment and bonding between children and their parents/caregivers; and

**WHEREAS**, The City will require the Museum of Children's Art to provide documentation for use of the Councilmember's priority project funds; now, therefore, be it

**RESOLVED:** That the City Council authorizes the grant of \$18,900 from Council President De La Fuente's priority project funds to the Museum of Children's Art in the amount of \$18,900 to fund intensive arts education programs serving 1,132 children in Oakland's Fruitvale neighborhood; and, be it

**FURTHER RESOLVED**: That the City Administrator is authorized to execute a grant agreement with the Museum of Children's Art consistent with the purposes of the grant, subject to approval as to form and legality by the City Attorney.
