#### **RECOMMENDATION**

Staff recommends that the City Council adopt the resolution accepting and confirming reports of the City Administrator on the costs incurred by the City Of Oakland for delinquent garbage service fees and confirming the recordation of liens with administrative and assessment charges as necessary – pursuant to Chapter 8.28 of the Oakland Municipal Code, and directing the notice of lien and assessment charges be turned over to the County Tax Collector for collection.

#### **OUTCOME**

Accordingly, 22 cases were resolved and removed from the list of delinquent properties. A resolution has been prepared confirming the placement of liens on 7,991 accounts (a list of delinquent accounts is available for review in the Office of the City Clerk, 1st floor City Hall) and authorizing the subsequent assessment for all fees and charges, should they remain unpaid at the time of submission to the County Assessor.

#### BACKGROUND/LEGISLATIVE HISTORY

Pursuant to Chapter 8.28 of the Oakland Municipal Code, administrative hearings were held to hear protests and resolve any inconsistencies or inequities regarding the delinquent mandatory garbage fees prior to the public hearing before City Council.

#### <u>ANALYSIS</u>

Waste Management of Alameda County billed the City \$1,105,912 which represents monthly charges for January through March 2012, and quarterly charges for April through June 2012. The bill is due and payable after the public hearing proceedings. Property owners owe the City delinquent garbage charges totaling \$1,105,912 and administrative fees totaling \$567,165 creating a grand total of \$1,673,077 for this period. The City will transfer all unpaid charges and fees to the Alameda County Tax Roll, and payments received through the County will be deposited in the City's Mandatory Garbage Fund (1700).
