**RESOLUTION CONFIRMING THE APPOINTMENT OF CARLA DARTIS  
AND THE REAPPOINTMENTS OF GREGORY HARTWIG, JANNY  
CASTILLO, BARBARA MONTGOMERY, AND WILLIAM MAYES TO  
THE OAKLAND HOUSING AUTHORITY BOARD**

**WHEREAS**, on April 28, 1938, the City Council passed Resolution No. 6341 C.M.S., establishing the Oakland Housing Authority Board pursuant to California Health and Safety Code section 34270; and

**WHEREAS**, the Oakland Housing Authority Board is responsible for Oakland's low-rent housing program with the Board providing policy oversight over the development, construction, rental, management and maintenance of all public housing in Oakland, so that the Board either owns, operates and administers its units or administers a rental assistance program in which private landlords rent directly to tenants who are eligible to receive federal rent subsidies; and

**WHEREAS**, California Health and Safety Code sections 34270 and 34272 (d), authorize the Mayor, subject to confirmation of a majority of the members of the City Council, to appoint Housing Authority Board members; and

**WHEREAS**, the Oakland Housing Authority Board, by authority of the California Health and Safety Code sections 34270 and 34272(d), consists of seven members, 5 of whom serve four-year terms in accordance with section 34270, with the other two being tenants of the authority, one of whom is over 62 years of age, each serving two-year terms; and

**WHEREAS**, the Honorable Mayor Barbara Lee has appointed Carla Dartis and reappointed Gregory Hartwig, Janny Castillo, Barbara Montgomery, and William Mayes as Commissioners to serve terms on the Oakland Housing Authority Board subject to confirmation by the City Council; now therefore be it

**RESOLVED**, that the City Council hereby confirms the Mayor's appointment and re-appointment of the following individuals to the Oakland Housing Authority Board for the terms set forth below:

**Carla Dartis**, as Commissioner, for the four (4) year term beginning July 1, 2025 and ending June 30, 2029.

**Gregory Hartwig**, as Commissioner, for the four (4) year term beginning July 1, 2025 and ending June 30, 2029.

**Janny Castillo**, as Commissioner, for the four (4) year term beginning July 1, 2025 and ending June 30, 2029.

**Barbara Montgomery**, as Commissioner, for the four (4) year term beginning July 1, 2025 and ending June 30, 2029.

**William Mayes**, as Commissioner, for the four (4) year term beginning July 1, 2025 and ending June 30, 2029.
