#### **SUMMARY**

The City Council's Annual Recess began August 1, 2003, and ended September 10, 2003. During the Annual Recess the Mayor was authorized to take such actions as would normally be taken by the City Council during the period of the Annual Recess except for duties reserved to the City Council by the City Charter, pursuant to Resolution No. 77709 C.M.S., dated March 25, 2003.

The City Council granted authorizations to the City Manager to take action on procurement of certain supplies and services exceeding \$500,000 and certain professional services contracts exceeding \$150,000 during the 2003 Annual Recess, pursuant to Resolution No. 78013 C.M.S., dated July 29, 2003.
