RESOLUTION AUTHORIZING THE APPROPRIATION AND ALLOCATION FROM COMPLETED PROJECTS AND \$1,346,246 EARNINGS FROM MEASURE K GENERAL OBLIGATION BONDS TO MOSSWOOD **PARK** IMPROVEMENTS, THE **TEMESCAL POOL** RENOVATION. AND PERALTA HACIENDA HISTORICAL **PARK** IMPROVEMENTS, AND AUTHORIZING \$240,000 IN MEASURE K SERIES D TRAIL IMPROVEMENT FUNDS FOR TWO TRAIL-CONNECTING BRIDGES IN JOAOUIN MILLER PARK AND CESAR CHAVEZ PARK

WHEREAS, the Measure K bond was passed by voters in 1990 to be used for open space acquisitions, park development projects and the Oakland Zoo restoration.

WHEREAS, \$1,093,323 is available from Measure K, Series D interest earnings and \$252,923 is available from completed projects in Measure K, Series C; and

WHEREAS, an additional \$92,000 is needed for the Moss House renovations; and

WHEREAS, an additional \$658,326 is needed to complete the Temescal Pool Filtration System replacement; and

WHEREAS, an additional \$595,920 is needed to supplement the Peralta Hacienda Historic Park restoration; and

WHEREAS, the City of Oakland cannot start spending Measure K, Series D interest earnings until January 2004; and

WHEREAS, \$240,000 is needed to complete two trail projects: the first, a bridge over Cinderella Creek in Joaquin Miller Park, and the second, a bridge over Peralta Creek in Cesar Chavez Park; and

WHEREAS, the stated projects are authorized Measure K projects; now, therefore, be it

RESOLVED: That \$1,093,323 of interest earnings be appropriated and \$252,923 from completed projects be reallocated from Measure K Series C and Series D as follows:

Moss House Renovation	\$92,000
Temescal Pool Filtration System	\$658,326
Peralta Hacienda Historic Park	<u>\$595,920</u>
TO	TAL \$1,346,246

FURTHER RESOLVED: That \$240,000 in existing funding from the Trail Improvements project be used for the following projects:

Trail bridge in Joaquin Miller Park \$170,000
Trail bridge in Cesar Chavez Park \$70,000
