INTRODUCED BY COUNCILMEMBER NANCY J. NADEL

RESOLUTION AUTHORIZING A GRANT OF \$850.00 FROM COUNCILMEMBER NANCY J. NADEL'S PAY-GO FUNDS TO LEADERSHIP EXCELLENCE FOR THE PURCHASE OF 100 BUS PASSES AT \$8.50 PER PASS TO BE USED AS AN INCENTIVE FOR WEST OAKLAND YOUTH TO PARTICIPATE IN A SURVEY SPONSORED BY THE TEEN PLANNING COMMITTEE FOR THE WEST OAKLAND TEEN CENTER

WHEREAS, on July 17, 2007, the City Council revised the Pay-Go procedures to limit Pay-Go uses to City of Oakland infrastructure, furniture or equipment expenditures, or to grants to other government agencies for infrastructure, furniture or equipment expenditures; and

WHEREAS, any expenditures for purposes other than City or other governmental infrastructure, furniture, or equipment require council approval; and

WHEREAS, Councilmember Nancy J. Nadel wishes to grant a portion of her Pay-Go funds to Leadership Excellence for the purchase of 100 bus passes at \$8.50 per pass to be used as an incentive for West Oakland Youth to participate in a survey sponsored by the Teen Planning Committee for the West Oakland Teen Center; and

WHEREAS, in conformance with City requirements, Leadership Excellence will provide documentation for the use of the Councilmember's Pay-Go funds; now, therefore, be it

RESOLVED, that the City Council authorizes the grant of \$850.00 from Councilmember Nancy J. Nadel's Pay-Go funds to Leadership Excellence for the purchase of 100 bus passes at \$8.50 per bus pass to be used as an incentive for West Oakland youth to participate in a survey sponsored by the Teen Planning Committee for the West Oakland Teen Center; and, be it

FURTHER RESOLVED, that the City Administrator is authorized to execute an appropriate grant agreement with Leadership Excellence for the above purpose, subject to approval as to form and legality by the City Attorney.
