

### RESOLUTION CONFIRMING THE MAYOR'S REAPPOINTMENT OF AMANDA MONCHAMP AND THE MAYOR'S APPOINTMENTS OF NISCHIT HEGDE AND SAHAR SHIRAZI TO THE CITY PLANNING COMMISSION

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of at least five members of the City Council; and

WHEREAS, Ordinance No. 192 C.M.S., as amended, created the City Planning Commission to consider and review matters related to planning, development and preservation and to advise the City Council on land use and environmental concerns; and

WHEREAS, the City Planning Commission consists of seven members serving three-year staggered terms with no more than two terms served consecutively; and

WHEREAS, the Honorable Mayor Libby Schaaf has reappointed Amanda Monchamp and appointed Nischit Hegde and Sahar Shirazi to each serve a three-year term on the City Planning Commission subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's reappointment of Amanda Monchamp to serve a three-year term on the City Planning Commission, beginning May 5, 2018 and ending May 4, 2021; retaining the seat she currently holds; and be it

FURTHER RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Nischit Hedge to serve a three-year term on the City Planning Commission, beginning May 5, 2018 and ending May 4, 2021, filling the seat previously held by Adhi Nagraj; and be it

FURTHER RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Sahar Shirazi to serve a three-year term on the City Planning Commission, beginning May 5, 2018 and ending May 4, 2021, filling the seat previously held by Emily Weinstein.
