RESOLUTION NO. _____ C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO A GRANT AGREEMENT WITH FRIENDS OF PERALTA HACIENDA HISTORICAL PARK IN A TOTAL AMOUNT NOT TO EXCEED FORTY-FIVE THOUSAND AND NINE HUNDRED DOLLARS (\$45,900) FOR FISCAL YEAR 2025-26 AND FORTY-FIVE THOUSAND AND NINE HUNDRED DOLLARS (\$45,900) FOR FISCAL YEAR 2026-27.

WHEREAS, the City Council wishes to provide grant funding to the entity identified in **Table 1** in the specified amounts for Fiscal Years 2025-26 and 2026-27; and

WHEREAS, funding for this grant has been approved by City Council as a General Purpose Fund appropriation in the Adopted Biennial Budget for Fiscal Years 2025-27; and

WHEREAS, the funding for this grant is available as part of the General Purpose Fund (1010), Cultural Assets Organization (90593), Third Party Grants Expenditure Account (54912), Hacienda Peralta Subsidy Project (1000616); and

WHEREAS, the General Purpose Fund grant funding appropriation for this grant is separate from any other City of Oakland funding that the above-named entity may receive in Fiscal Years 2025-27, including funds allocated from other funding sources, through separate grant or contractual agreements, or through voter-approved measures; now, therefore, be it

RESOLVED: That the City Council awards a grant to the entity identified in **Table 1** in the specified amounts therein for Fiscal Years 2025-27 to fund its youth and community programs, coordinate and manager a volunteer program, and address maintenance and repairs at the Hacienda Historical Park's historic house and grounds, and be it

FURTHER RESOLVED: That the City Administrator is authorized to negotiate, draft, and execute a grant agreement with Friends of Peralta Hacienda Historical Park in an amount not to exceed Forty-Five Thousand and Nine Hundred dollars (\$45,900) for FY 2025-2026 and Forty-Five Thousand and Nine Hundred dollars (\$45,900) for FY 2026-27.
