My work assignments in the last few years have ranged from working with the Marguerite Casey Foundation's Equal Voice for America's Families campaign as the national content director for a 10,000 plus person convention to working to create a learning community with the program officers worldwide of the Media, Arts and Culture division of the Ford Foundation, to the 2025 Campaign for Black Men and Boys.

In my work life, I have had the opportunity to meet hundreds of people from the community development, public health, arts, community activism, and political communities. In all of my experiences, I have rarely met and worked with anyone as committed to the overall prosperity, health and well-being of our community than Adhi. He is indeed a special asset to our city, region and nation.

I met Adhi in 2006 when he joined the Train Station Partnership, a community coalition dedicated to restoring the Southern Pacific station in West Oakland. We have served together on the RAILS board since 2009. From the time 1 became acquainted with him until today, I have found him to be one who listens to all perspectives, weighs the options carefully, applies sound analysis to the challenges at hand and then respectfully proposes his solution or point of view.
