RESOLVED: That the City Council authorizes the grant of \$500 of Councilmember Patricia Kernighan's Priority Project Funds to the Chinatown Chamber of Commerce for expenses incurred in connection with the Community Celebration for installation of pedestrian safety-improvements at four Chinatown intersections, and be it

FURTHER RESOLVED: that the City Administrator is authorized to execute an appropriate grant agreement with the Chinatown Chamber of Commerce consistent with the purposes of the grant, subject to approval as to form and legality by the City Attorney.
