

RESOLUTION No. 88883 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE GRANT FUNDS IN THE AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000) FROM THE STATE OF CALIFORNIA, OFFICE OF TRAFFIC SAFETY (OTS), FOR THE FISCAL YEAR 2021-2022 SELECTIVE TRAFFIC ENFORCEMENT PROGRAM (STEP), TO BE ADMINISTERED BY THE OAKLAND POLICE DEPARTMENT (OPD); AND TO AUTHORIZE THE GENERAL PURPOSE SERVICES FUND TO CONTRIBUTE SIXTY NINE THOUSAND FIVE HUNDRED FIFTY DOLLARS (\$69,550) TO COVER THE RELATED CENTRAL SERVICES OVERHEAD CHARGES.

WHEREAS, the Selective Traffic Enforcement Program (STEP), from the State of California, Office of Traffic Safety (OTS), is designed to reduce the number of people injured or killed in crashes involving alcohol, speed, red light running, and other primary collision factors through the combined efforts of OTS and local law enforcement agencies; and

WHEREAS, grant funds totaling Five Hundred Thousand Dollars (\$500,000) have been awarded by OTS for OPD's continued participation in STEP for the current fiscal year; and

WHEREAS, the FY2020-21 STEP grant award period of performance is October 1, 2021 through September 30, 2022; and

WHEREAS, OTS does not allow STEP grant awards to be used for indirect overhead costs; and

WHEREAS, the City Council previously authorized acceptance of similar OTS STEP grant funds by Resolution No. 88403 C.M.S, dated December 1, 2020, Resolution No. 87878 C.M.S, dated September 12, 2019, Resolution No. 87363 C.M.S., dated October 16, 2018, Resolution No. 86958 C.M.S., dated November 7, 2017, Resolution No. 86491 C.M.S. dated November 29, 2016, Resolution No. 85274 C.M.S., dated October 30, 2014, Resolution No. 83555 C.M.S., dated September 20, 2011, Resolution No. 81223 C.M.S., dated April 15, 2008, Resolution No. 80578 C.M.S., dated May 15, 2007, and Resolution No. 80130 C.M.S., dated September 19, 2006; therefore be it

RESOLVED: That the City Council does hereby authorize the City Administrator to accept and appropriate a grant award in the amount of five hundred thousand dollars (\$500,000) from the State of California, OTS; and be it

FURTHER RESOLVED: That the City Council does hereby authorize all central services overhead charges associated with this grant in an estimated amount of sixty-nine thousand, five hundred fifty dollars (\$69,550) to be offset through a contribution of the General Purpose Fund; and be it

FURTHER RESOLVED: That the grant funds shall be maintained in the State of California Grant Fund: 2159, Traffic Enforcement Division Org.: 107510; Traffic Enforcement Program: PS14, in Project: 1006057 and award: 24017; and be it

FURTHER RESOLVED: That the City Council hereby authorizes the City Administrator or designee to act as an agent to conduct all negotiations and related actions and to sign all applications and agreements that may be necessary for the completion of the aforementioned grant.


