RESOLUTION NO. _____ C.M.S.

RESOLUTION AWARDING GRANT AGREEMENTS TO EDEN I&R, INC. TO PROVIDE 2-1-1 REFERRAL SERVICES IN AN AMOUNT NOT TO EXCEED \$100,000 PER YEAR FOR FISCAL YEARS 2023-2025 AND TO SERVICE OPPORTUNITY FOR SENIORS (SOS) TO ADMINISTER THE MEALS ON WHEELS FOOD DELIVERY PROGRAM IN AN AMOUNT NOT TO EXCEED \$150,000 PER YEAR FOR FISCAL YEARS 2023-2025

WHEREAS, on June 26, 2023, the City Council adopted the Fiscal Year (FY) 2023-25 biennial budget (Resolution No. 89804 C.M.S.), that appropriated funds for the expenditures proposed by said budget; and

WHEREAS, on December 5, 2023, the Oakland City Council adopted Resolution No. 90005 C.M.S. that awarded some of the grants that were appropriated in the Adopted Biennial Budget for FY 2023-25, including \$90,318 per year for Eden I&R, Inc.; and

WHEREAS, on March 19, 2024, the Oakland City Council adopted Resolution No. 90157 C.M.S. that awarded grants in the amount of \$300,000 per year to Service Opportunity for Seniors (SOS) from Measure BB funds that were appropriated in the Adopted Biennial Budget for FY 2023-25; and

WHEREAS, the second award grant for Eden I&R, Inc. and a second award grant for Service Opportunities for Seniors (SOS) were left off Resolution Nos. 90005 C.M.S. and 90157 C.M.S. in error, while listed as awarded grants appropriated in the Adopted Biennial Budget for FY 2023-25; and

WHEREAS, the Adopted Biennial Budget for FY2023-25 appropriated an additional one hundred thousand dollars (\$100,000) per year in General Purpose Fund (1010), CSBG Admin Org (78361) Expand 211 Help Project (1000412), Fostering Safe and Healthy Communities Program (SC22), for Eden I&R, Inc. for 2-1-1 referral services and appropriated an additional one hundred and fifty thousand dollars (\$150,000) per year in General Purpose Fund (1010), Senior Center Org (75631), Meals on Wheels Project (1003725), Empowering Seniors & People with Disability (YS14), for SOS Meals on Wheels; and

WHEREAS, the 2-1-1 Referral Services provided by Eden I&R, Inc. is a vital piece of the community infrastructure and the Meals on Wheels program, provided by the Service Opportunity for Seniors organization, delivers nutritious meals to homebound seniors and supports the equitable treatment of senior populations with language, cultural, and other critical needs; and

WHEREAS, the City Council wishes to expedite the issuance of this grant to improve the lives of Oakland community members; and

WHEREAS, the City Council wishes to provide grant funding to the following entities for community-related services and activities in the specific amounts for FY 2023-25:
