RESOLUTION AUTHORIZING AWARD OF A CONTRACT TO ANDES CONSTRUCTION INC. FOR THE REHABILITATION OF SANITARY SEWERS AT VARIOUS LOCATIONS-OAK STREET, LOCARNO PATH, THE EASEMENT BETWEEN ACACIA AVENUE AND MARGARIDO DRIVE, POPLAR STREET, FLORIDA STREET, ALONG THE PATH BETWEEN LONGRIDGE AND SUNNYHILLS ROADS, AND THE EASEMENT BETWEEN MANZANITA DRIVE AND SKYLINE BOULEVARD (PROJECT NO. C171110) FOR THE AMOUNT OF ONE HUNDRED SEVENTY-FIVE THOUSAND SEVENTY-THREE DOLLARS (\$175,073)

WHEREAS, the Rehabilitation of Sanitary Sewers at Various Locations-Oak Street, Locarno Path, the easement between Acacia Avenue and Margarido Drive, Poplar Street, Florida Street, along the Path between Longridge and Sunnyhills Roads, and the easement between Manzanita Drive and Skyline Boulevard (Project No. C171110), is consistent with the Mayor/City Council Goal and Citywide Objective to maintain and enhance Oakland Physical Assets; and

WHEREAS, on June 9, 2003, two bids were received by the Office of the City Clerk of the City of Oakland for the Rehabilitation of Sanitary Sewers at Various Locations-Oak Street, Locarno Path, the easement between Acacia Avenue and Margarido Drive, Poplar Street, Florida Street, along the Path between Longridge and Sunnyhills Roads, and the easement between Manzanita Drive and Skyline Boulevard (Project No. C171110); and

WHEREAS, Andes Construction Inc. a certified SLBE bidding as a prime is the lowest responsible bidder for the project; and

WHEREAS, Andes Construction Inc. complies with all LBE/SLBE requirements; and

WHEREAS, there are sufficient funds in Fund 3100, Project C171110, for the contract work; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy or better performance; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now, therefore, be it

RESOLVED: That the contract for the Rehabilitation of Sanitary Sewers at Various Locations-Oak Street, Locarno Path, the easement between Acacia Avenue and Margarido Drive, Poplar Street, Florida Street, along the Path between Longridge and Sunnyhills Roads, and the

easement between Manzanita Drive and Skyline Boulevard is hereby awarded to Andes Construction Inc. in accordance with the terms of its bid therefore, dated June 9, 2003, for the amount of One Hundred Seventy-Five Thousand Seventy-Three Dollars (\$175,073); and be it

FURTHER RESOLVED: That the amount of the bond for faithful performance, \$87,536.50 and the amount for a bond to guarantee payment of all claims for labor and materials furnished and for the amount due under the Unemployment Insurance Act, \$175,073 with respect to such work are hereby approved; and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to enter into a contract with Andes Construction Inc. on behalf of the City of Oakland and to execute any amendments or modifications to said agreement within the limitations of the project specifications; and be it

FURTHER RESOLVED: That all other bids are hereby rejected; and be it

FURTHER RESOLVED: That the contract shall be reviewed and approved by the City Attorney and placed on file in the Office of the City Clerk; and be it

FURTHER RESOLVED: That the approval of this Resolution requires a two-thirds vote of the Council members.
