

RESOLUTION No. 87548 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO AWARD A CONTRACT TO FRANCISCO ELECTRIC SUPPLY, A CORPORATION, THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, A SMALL LOCAL BUSINESS ENTERPRISE TO PROVIDE STREET LIGHT TRAFFIC SIGNAL STANDARDS AND ACCESSORIES IN THE AMOUNT NOT TO EXCEED ONE MILLION, SEVEN HUNDRED NINETY-SEVEN THOUSAND EIGHT HUNDRED NINETEEN DOLLARS AND NINE CENTS (\$1,797,819.09) FOR THE PERIOD OF MARCH 4, 2019 TO MARCH 3, 2020 IN ACCORDANCE WITH THE TERMS AND CONDITIONS IN SPECIFICATION 19-285-00/RFQ 130425.

WHEREAS, on September 17, 2018 in accordance with Oakland Municipal Code (OMC) 2.04.050 the City issued and advertised Specification No. 19-285-00/ RFQ 130425 to provide Street Light Traffic Signal Standards and Accessories; and

WHEREAS, on October 22, 2018 the City Clerk received and opened bids in response to Specification No. 19-285-00/ RFQ 130425; and

WHEREAS, the bid submitted by Francisco Electric Supply was evaluated and deemed the lowest responsive and responsible bidder and meets all the requirements contained in Specification No. 19-285-00/ RFQ 130425 to provide Street Light Traffic Signal Standards and Accessories; and

WHEREAS, all proposed contract expenditure allocations shall be expensed to the Oakland Public Works Electrical Services Division, Bureau of Infrastructure and Operations, Lighting and Landscape Assessment District, Electrical Services: Maintenance Organization, Supplies: Electrical and Plumbing now, therefore be it.

RESOLVED, that a contract be awarded to Francisco Electric Supply, a company, the lowest responsive and responsible bidder, a small local business enterprise, in an amount not to exceed one million seven hundred ninety-seven thousand eight hundred nineteen dollars and nine cents (\$1,797,819.09) for the period of March 4, 2019 to March 3, 2020 to provide Street Light Traffic Signal Standards and Accessories; and

FURTHER RESOLVED, that the City Council hereby rejects all other bids submitted in response to Specification No. 19-285-00/ RFQ 130425; and

FURTHER RESOLVED, that the contract shall be approved for form and legality by the City Attorney and copies shall be on file in the City Clerk's Office.


