Dear President De La Fuente and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney recommends settlement of the above-entitled matter arising from alleged civil rights violations during the arrest of the plaintiff for a total sum of Thirty-Seven Thousand Dollars and No Cents (\$37,000.00), to be made payable to Lester Austin and Garet O'Keefe, Esq., his attorney.

Plaintiff alleges excess force was used during his arrest on February 22, 2000. Mr. Austin claims that the officer struck him with a flashlight. The settlement is recommended to avoid the risk of an adverse verdict at trial and the additional exposure for attorney's fees should that occur. This case was discussed in closed session October 18, 2005.
