President De La Fuente and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney recommends settlement of the above-entitled matter arising out of an alleged dangerous condition of a sidewalk on a city street. Plaintiff Eula McClure was injured on June 13, 2000, when an Oakland Police car rear-ended her vehicle on Interstate 580. Ms. McClure suffered a herniated disk, torn rotator cuff and back injuries.

Due to the risk of an adverse jury verdict under the circumstances, settlement is recommended for the sum of Forty-Five Thousand Dollars and No Cents (\$45,000.00), to be made payable to Ms. Eula McClure and her counsel.
