**RESOLUTION CONFIRMING THE MAYOR'S REAPPOINTMENT OF
KEVIN CHOICE, J. K. FOWLER, MICHELLE LEE, DIANE SANCHEZ,
AND THEO AYTCHAN WILLIAMS TO THE CULTURAL AFFAIRS
COMMISSION**

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No. 11323 C.M.S., amended by Ordinance Nos. 11778 C.M.S. and 13561 C.M.S., establishes the Cultural Affairs Commission as a professionally qualified citizen committee responsible for advising the City regarding all matters affecting arts and cultural development in the City of Oakland; and

WHEREAS, Ordinance No. 13561 C.M.S. provides that all terms shall commence on October 1 and end on September 30, and for the initial appointment only, four members shall be appointed for a three-year term, four members shall be appointed for a two-year term, and three members shall be appointed for a one-year term, and thereafter, all appointments shall be for three years; and

WHEREAS, Ordinance No. 13561 C.M.S. provides that no person shall be appointed to serve as a member of the Cultural Affairs Commission for more than two consecutive three-year terms plus any initial term of less than two years; and

WHEREAS, the Honorable Mayor Libby Schaaf has reappointed Kevin Choice, J. K. Fowler, Michelle Lee, Diane Sanchez and Theo Aytchan Williams to serve a three year term on the Cultural Affairs Commission; now therefore, be it,

RESOLVED: That the City Council hereby confirms the Mayor's reappointment of:

Kevin Choice, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2021 and ending September 30, 2024.

J. K. Fowler, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2021 and ending September 30, 2024.

Michelle Lee, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2021 and ending September 30, 2024.

Diane Sanchez, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2021 and ending September 30, 2024.

Theo Aytchan Williams, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2020 and ending September 30, 2023.


