INTRODUCED BY COUNCIL PRESIDENT PRO TEMPORE NOEL GALLO

RESOLUTION APPOINTING COUNCILMEMBER ROWENA BROWN TO THE EXECUTIVE BOARD OF THE EAST BAY COMMUNITY ENERGY AUTHORITY JOINT POWERS AUTHORITY (EBCEA) AND APPOINTING COUNCILMEMBER ZAC UNGER AS AN ALTERNATE TO THE EXECUTIVE BOARD OF THE EAST BAY COMMUNITY ENERGY AUTHORITY JOINT POWERS AUTHORITY (EBCEA) FOR TERMS COMMENCING JANUARY 1, 2025, AND ENDING DECEMBER 31, 2026

WHEREAS, the City Council elected to implement a Community Choice Energy program within the City's jurisdiction through its participation in the East Bay Community Energy Authority (EBCEA) and

WHEREAS, Article 4.2.1 of the East Bay Community Energy Authority Joint Powers Agreement states that "The governing body of each Party shall appoint and designate in writing one regular Director who shall be authorized to act for and on behalf of the Party on matters within the powers of the Authority. The governing body of each Party also shall appoint and designate in writing one alternate Director who may vote on matters when the regular Director is absent from a Board meeting. The person appointed and designated as the regular Director shall be a member of the governing body of the Party. The person appointed and designated as the alternate Director shall also be a member of the governing body of the Party"; and

WHEREAS, the City of Oakland may appoint one Director and one Alternate to the East Bay Community Energy Authority JPA Board; and

WHEREAS, Councilmember Rowena Brown has the subject matter interest, expertise, and experience to serve as the primary member for Oakland on the EBCEA Executive Board; and

WHEREAS, Councilmember Zac Unger has been selected as an alternate to the EBCEA Executive Board, with an understanding of the City's energy priorities and a commitment to supporting Oakland's involvement in the Authority; and

WHEREAS, the City Council's Rules of Procedure (Resolution No. 82580 C.M.S.) state that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; now, therefore, be it

RESOLVED, that Councilmember Rowena Brown is appointed as a regular member of the Executive Board of the East Bay Community Energy Authority Joint Powers Authority (EBCEA) for terms commencing January 1, 2025, and ending December 31, 2026; and be it

FURTHER RESOLVED, that Councilmember Zac Unger is appointed as an alternate member to the Executive Board of the East Bay Community Energy Authority Joint Powers Authority (EBCEA) for terms commencing January 1, 2025, and ending December 31, 2026.


