SUMMARY

BACKGROUND

The Oakland City Council contributes funds every year to support projects and services that will benefit the Oakland Community. To ensure accountability for all contributions, the Finance and Management Committee directed the Controller to identify, research, inquire, and document activities that were supported by donated Funds to external organizations.

▪ **Determination of Funds Donated to External Organizations:**

Detailed reports from July 01, 2004 through June 15, 2006 for all Council Member expenditures were analyzed. Expenditures were classified as a donation when the payment was made to an external organization and was not the result of a contract, purchase order, or invoice.




