## RESOLUTION REAPPOINTING PETER BARNETT, JOANNE BROWN, AND MARA VELEZ AS MEMBERS OF THE VIOLENCE PREVENTION AND PUBLIC SAFETY OVERSIGHT COMMITTEE

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, the Violence Prevention and Public Safety Act of 2004, also known as Measure Y, adopted by the voters of Oakland in the November 2, 2004 General Municipal Election and Ordinance No. 12690, adopted by the City Council July 19, 2005, create the Violence Prevention and Public Safety Oversight Committee to oversee and monitor the activities and procedures of the Violence Prevention and Public Safety Act; and

**WHEREAS**, the Violence Prevention and Public Safety Act of 2004 specifies that members of the Violence Prevention and Public Safety Oversight Committee are to be appointed one by each Member of the City Council and three members by the Mayor, to serve unlimited one-year terms; and

**WHEREAS**, the Honorable Mayor Jean Quan has reappointed the following to serve a one-year term subject to confirmation by the City Council; now therefore, be it

**RESOLVED**, that pursuant to City Charter section 601; the City Council hereby confirms the Mayor's appointment of:

**Peter Barnett** Mayoral reappointment upon the recommendation of Councilmember Noel Gallo for District 5 Representative to serve the term beginning March 17, 2014 and ending March 16, 2015, filling the seat he previously held.

**Joanne Brown** Mayoral reappointment upon the recommendation of Councilmember Dan Kalb for District 1 Representative to serve the term beginning April 19, 2014 and ending April 18, 2015, filling the seat she previously held.

**Mara Velez** Mayoral reappointment upon the recommendation of Council President Patricia Kernighan for District 2 Representative to serve the term beginning July 6, 2014 and ending July 5, 2015, filling the seat she previously held.
