RESOLUTION:

- 1) **ACCEPTING, APPROPRIATING, AND AUTHORIZING AN AGREEMENT FOR RECEIPT OF GRANT FUNDS IN AN AMOUNT NOT TO EXCEED \$100,000 FROM THE ALAMEDA COUNTY SOCIAL SERVICES AGENCY FOR CONTINUED OPERATION OF THE INFORMATION AND ASSISTANCE (I&A) PROGRAM FOR OAKLAND SENIORS FOR FISCAL YEAR (FY) 2022-23; AND**
- 2) **AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE ANY ADDITIONAL FUNDS FROM ALAMEDA COUNTY SOCIAL SERVICES AGENCY FOR THE I&A PROGRAM WITHIN FY 2022-23; AND**
- 3) **AUTHORIZING A CONTRIBUTION FROM THE GENERAL PURPOSE FUND IN AN AMOUNT EQUIVALENT TO THE CENTRAL SERVICES OVERHEAD CHARGES IN AN ESTIMATED AMOUNT OF \$29,060 FOR FY 2022-2023**

WHEREAS, in Oakland, 30 percent of elderly persons who are fifty years of age and older live below the poverty level; and

WHEREAS, local governments have played an important role in assisting elderly persons in maintaining their standard of living; and

WHEREAS, the Human Services Department's (HSD) Aging and Adult Services Information and Assistance (I&A) Program links older adults who need assistance to the appropriate service(s) within the communities and, to the maximum extent practicable, establishes adequate follow-up procedures; and

WHEREAS, the City desires to continue to support the I&A Program by accepting this program baseline funding from the Alameda County Social Services Agency, Area Agency on Aging; and

WHEREAS, the HSD is requesting as it has in prior years, a contribution from the General Purpose Fund in an amount equivalent to Central Services Overhead charges in an estimated amount of \$29,060 for FY 2022-2023; now, therefore, be it

RESOLVED: That the City Council hereby accepts, appropriates, and authorizes an agreement for receipt of a grant in an amount not to exceed \$100,000 for FY 2022-23 from the Alameda County Social Services Agency for continued operation of the Information and Assistance (I&A) program for Oakland seniors; and be it

FURTHER RESOLVED: That the funds will be appropriated in Human Services Department Social Services Grant Fund (2160), HSD Outreach Program Organization (75251), Outreach Program Project/Award (1005544/23373) and Empowering Senior and People with Disabilities Program (YS14); and be it

FURTHER RESOLVED: That all Central Services Overhead charges, in an estimated amount of \$29,060 for FY 2022-23, associated with this grant will be offset through a contribution of the General Purpose Fund; and be it

FURTHER RESOLVED: That if additional grant funding becomes available from the Alameda County Social Services Agency, for the same purpose for FY 2022-23, the City Administrator or designee is hereby authorized to accept and appropriate these funds for the I&A Program, and amend the grant agreement with Alameda County Social Services Agency as may be necessary.


