**AN ORDINANCE:  
AMENDING THE SALARY SCHEDULE OF ORDINANCE NO. 12187 C.M.S.  
("SALARY ORDINANCE") TO: (A) ADD THE FULL-TIME CLASSIFICATION  
OF MANAGER, CONTRACTING AND PURCHASING; MOBILE ASSISTANCE  
COMMUNITY RESPONDERS OF OAKLAND (MACRO) SUPERVISOR; VIO-  
LENCE PREVENTION PROGRAM PLANNER; HOME BASE SPECIALIST;  
AND HOME BASE VISITOR; AND (B) AMEND THE TITLE OF THE  
FULLTIME CLASSIFICATION OF ANIMAL CONTROL & SHELTER MANA-  
GER TO ANIMAL SHELTER OPERATIONS MANAGER; AND (C) AMEND  
THE SALARY OF THE FULL-TIME CLASSIFICATION OF DIRECTOR OF  
TRANSPORTATION; AND (D) AMEND THE SALARY OF THE PART-TIME  
CLASSIFICATIONS OF SENIOR AIDE, PT AND TEMPORARY CONTRACT  
SERVICES EMPLOYEE, PT TO ENSURE COMPLIANCE WITH THE CITY OF  
OAKLAND'S MINIMUM WAGE ORDINANCE.**

**Notice of Publication**

This ordinance authorizes changes to the City's Classification Plan as shown in the City's Salary Schedule to add new classifications and amend existing titles and salary rates. Four departments are requesting new classifications to align with operational and service delivery needs. This applies to the Manager, Contracting and Purchasing in the Finance Department, MACRO Supervisor in OFD, Violence Prevention Program Planner in DVP, and Home Base Specialist and Home Base Visitor in HSD. A title change applies to the Animal Shelter Operations Manager classification in OAS. The pay rate for the Director of Transportation classification is being modified to align with the salary rate of other similarly situated department head positions. Lastly, the pay rates for the Senior Aide, PT and Temporary Contract Services Employee, PT classifications are being raised to align with the City of Oakland's new minimum wage rate that took effect January 1, 2024 per requirements in Measure FF and the Oakland Municipal Code Section 5.92

This Ordinance was introduced at the Special City Council meeting, Wednesday evening **March 6, 2024**, and passed to print **5 Ayes, 3 Excused, Fife, Ramachandran, Reid**. Final adoption has been scheduled for the City Council meeting **Tuesday, March 19, 2024, 3:30 P.M.**, at One Frank H. Ogawa Plaza, Council Chamber, 3rd floor, Oakland, California and via Teleconference.
