RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AN IN-KIND TECHNICAL ASSISTANCE AWARD VALUED AT ONE MILLION DOLLARS (\$1,000,000) FOR THE PERIOD OF OCTOBER 1, 2025, TO JUNE 30, 2029, AND TO ENTER INTO A NO-COST AGREEMENT WITH GREENLIGHT FUND AND URBAN PEACE INSTITUTE IN SUPPORT OF THE DEVELOPMENT OF A COMMUNITY VIOLENCE INTERVENTION ACADEMY IN OAKLAND FOR A FOUR-YEAR TERM

WHEREAS, the City of Oakland's Department of Violence Prevention (DVP) is mandated to reduce gun violence, intimate partner violence, and commercial sexual exploitation in Oakland; and

WHEREAS, the DVP achieves its mandates by: (1) employing a team of direct service staff to deliver intensive life coaching and violence interruption services to individuals at the highest risk of near-term group violence, (2) funding community-based organizations to deliver services to individuals at the center of group violence, intimate partner violence, and commercial sexual exploitation in Oakland, and (3) providing training and capacity-building opportunities to the ecosystem of community violence intervention workers in Oakland; and

WHEREAS, the DVP's work is part of a national field of practice known as community violence intervention, which focuses on proven strategies and services directed toward individuals most likely to engage in or be affected by violence in the near term; and

WHEREAS, to sustain high-quality community violence intervention work in Oakland and the greater Bay Area, the City would benefit from establishing an academy to train and certify individuals as community violence intervention workers; and

WHEREAS, GreenLight Fund is a national philanthropic organization that identifies persistent social issues in specific communities and funds national experts to help implement evidence-based solutions through multi-year technical assistance; and

WHEREAS, in May 2025, GreenLight Fund selected the DVP through a competitive process to receive four years of technical assistance from Urban Peace Institute, a nonprofit that has established a successful community violence intervention academy in Los Angeles, to support the creation of a similar academy in Oakland; and

WHEREAS, the DVP desires to enter a no-cost agreement with GreenLight Fund and Urban Peace Institute to outline the roles and responsibilities of each entity during the four-year term of this collaboration; and

WHEREAS, prior to execution, the agreement shall be reviewed and approved as to form and legality by the Office of the City Attorney and placed on file in the Office of the City Clerk; now, therefore, be it

RESOLVED: That the City Administrator is authorized to accept an in-kind technical assistance award valued at one million dollars (\$1,000,000) for the period of October 1, 2025, to June 30, 2029, and to enter an agreement with GreenLight Fund and Urban Peace Institute, for a term of four years, that will allow the DVP to receive technical assistance from Urban Peace Institute, funded by GreenLight Fund, to establish a community violence intervention academy in Oakland.
