A Follow Up Report from the Chief of Police on Efforts to Address the Issue of

Minors Involved in Prostitution in Oakland

SUMMARY

This report responds to the Committee's request for additional information and statistics on the Oakland Police Department's efforts to reduce incidents of minors being prostituted in the City of Oakland.

FISCAL IMPACT

This is an information report providing statistics on law enforcement operations regarding minors in prostitution. Fiscal impacts are not included

BACKGROUND

On February 8, 2005 the Police Department presented a report on the "Alameda County Minors in Prostitution Task Force Report," dated October 2003. The report also noted the efforts of the Police Department's Special Victims Section to address the issue.

Officers currently encounter between three to fourteen minors engaging in prostitution each week. It is common practice for pimps to recruit teenage girls from local middle and high schools, and then encourage these prospects out onto the street through a combination of smooth talk, money, clothes, drugs and for many, a feeling of being wanted or needed. Many of these young women are the victims of child abuse and/or sexual abuse and are often living at or below the poverty level.

KEY ISSUES AND IMPACTS

Operations

In June 2004, the Child Exploitation / Vice Unit was transferred to the Special Victims Section from the Special Operations Division. Since its transfer, the combined unit has conducted four major street operations. The operations targeted pimps, their customers, and sex workers who use the streets of Oakland to conduct business. These special operations produced the following arrest results:

- 154 "johns"
- 10 "pimps," two armed with firearms
- 64 sex workers, 10 of whom were minors

These statistics do not include the twenty-nine (29) vice operations conducted on a smaller scale throughout the year, which resulted in the following:

- 800 adult arrests for soliciting a prostitute
- 104 juvenile arrests for soliciting a prostitute
- 22 adult arrests for pimping / pandering
- 80 citations for loitering for the purpose of prostitution

The listed operations averaged 35.4 arrests per event.

Target Locations

The target locations were as follows:

- San Pablo Avenue corridor, between W. Grand Avenue & the City of Berkeley border
- International Boulevard corridor, between 1st Avenue and the City of San Leandro border
- West MacArthur Boulevard corridor, between San Pablo Avenue & Broadway
- 17th Avenue at International Boulevard
- 38th Avenue at International Boulevard
- 54th Avenue at International Boulevard
- High Street at International Boulevard (This location has recently experienced the highest concentration of sexually exploited minors)

Staffing

The Special Victims Section is staffed with thirty-three sworn members.

- One lieutenant
- Three sergeants, one administrative and two supervisory
- Twenty-two (22) investigators
- Five intake desk officers
- Three civilian support staff

One of the investigators is currently on long-term maternity leave. Another investigator has been on a loan assignment to the Information Technology Unit for the last two years. Three of the 22 listed investigators are currently assigned to the Child Exploitation / Vice Unit. Two additional

Item: _____ Public Safety Comte. April 12, 2005 officers, normally assigned to this unit, are on active military duty in Iraq and are not expected to return until Summer 2005.

When vice officers are not conducting prostitution operations they are assigned to investigate sexual assault and child exploitation cases. One officer oversees massage parlor operations. In 2004 the section had one officer assigned to investigate and monitor registered sex offenders. However this position was lost in 2005.

Sexually Exploited Minors Statistics

As noted in the 2003 Minors in Prostitution Task Force Report, there is no municipal or county system currently available to measure teen prostitution arrests or prosecutions. This omission resulted in the report's:

Recommendation #5: The Planning and Implementation of a Data Collection Strategy to Accurately Capture Basic Information Related to Sexually Exploited Youth in Alameda County.

"As stated earlier in this report, there is virtually no aggregate hard data related to sexually exploited youth in Alameda County. In order to inform the development of effective local and inter-county protocols and service response systems, it will be critical to have consistent and reliable information related to sexually exploited minors. It is therefore strongly recommended that the different data collecting entities located within the County and Cities (the CAPE Unit and the Oakland Police Department, for example) be convened to discuss ready available options (i.e. existing data collection activities that might be enhanced) as well as new data gathering strategies."

A meeting of the collecting entities will be convened once the East Bay Task Force on Human Trafficking is formed (anticipated June 2005). A three-year, \$450,000, Department of Justice, Human Trafficking grant has been awarded to fund the Task Force and to develop a database. The database will capture the information for minors and prostitution as well as other forms of human trafficking.
