

RESOLUTION HONORING USANA HOPKINS, EARLY CHILDHOOD AND FAMILY SERVICES MANAGER, UPON HER RETIREMENT AFTER 24 YEARS OF DEDICATED PUBLIC SERVICE TO THE CITY OF OAKLAND

WHEREAS, Usana Hopkins, began her career at the City of Oakland in August of 1992, as a Child Care Coordinator, providing staff support to the Child Care Advisory Commission, developing Council reports, letters and proposals; assisted with the creation of materials for publication including news releases, reviewed and made recommendations on local, state, and national legislation regarding child care, and provided resource information to various City departments, local businesses and organizations regarding child care; and

WHEREAS, Usana Hopkins from August of 1993 through November of 1996, as the Child Care Coordinator, implemented the activities of the Head Start Family Child Care (FCC) research project, developed proposals for future funding, monitored FCC budget and ordered necessary supplies, and developed reports for Policy Council, and City Council; and

WHEREAS, Usana Hopkins, in November of 1996, became the Projects and Program Manager for the City of Oakland, and worked with the Mayor's Oakland 2000 Ready to Learn Project and the Pedestrian Safety Project, and assisted with the development of program budgets, grant proposals and worked with other City Agency's on various projects, and in November of 1996 through July of 2000, became the Head Start Program Planner and Monitor, coordinating the effective service delivery systems in 21 Head Start centers and 7 Family Child Care Homes in the areas of health, disabilities, nutrition, education, family services, and facilities in accordance with the Head Start Performance Standards; and

WHEREAS, Usana Hopkins served on the Alameda County Child Care Planning Council and networked with various social service organizations, and in July of 2000 became the Director of the Head Start/Early Head Start Program, which served more than 1700 children and families, while implementing the Head Start program's strategic planning process, while serving as the liaison to businesses and community

organizations, foundations, and the Oakland Unified School District, and, created the first downtown child development center as part of a 5 year strategic plan to enhance the development and economic growth of the City of Oakland's downtown corridor; and

WHEREAS, Usana Hopkins'entire working career has been in the field of education from teaching to administration/directorship for a total of 38 years, and she loves listening to contemporary jazz, dancing, gardening, and watching a beautiful sunset, now, therefore, be it:

RESOLVED: That on behalf of the Oakland City Council, the undersigned, hereby commends Usana Hopkins for her kind spirit, her faithfulness, and her dedication and commitment to serving the citizens of Oakland; and be it:


