INTRODUCED BY COUNCIL PRESIDENT KAPLAN

RESOLUTION AMENDING RESOLUTION NO. 88174 C.M.S., WHICH ADOPTED THE 2020-21 MID-CYCLE BUDGET AMENDMENTS, TO REALLOCATE COVID RELIEF FUNDS FOR ADDITIONAL OR ALTERNATIVE PROGRAMS AND ACTIVITIES TO RESPOND TO THE COVID-19 PUBLIC HEALTH EMERGENCY

WHEREAS, on June 23, 2020, City Council passed Resolution 88174 C.M.S., which adopted the 2020-21 Mid-Cycle Budget Amendments; and

WHEREAS, the Mid-Cycle Budget Amendments adopted by the City Council included an allocation of twenty-six million nine hundred thousand dollars (\$26,900,000) in COVID relief funds for various programs and activities to respond to the COVID-19 public health emergency; and

WHEREAS, the COVID relief fund allocations can be found at pages 5-6 of Exhibit 5 to Resolution 88174 C.M.S.; and

WHEREAS, the City Council wishes to reallocate COVID relief funds for additional or alternative programs and activities to respond to the COVID-19 public health emergency; now, therefore, be it

RESOLVED: That the City Council reallocates COVID relief funds for additional or alternative programs and activities to respond to the COVID-19 public health emergency as set forth in the redlined modifications to pages 5-6 of Exhibit 5 to Resolution 88174 C.M.S. attached hereto as **Attachment 1**.
