

A Resolution Renaming "Broadway" Between 5th Street and 6th Street and Under I-

580 to "Broadway Auto Row"

SUMMARY

Caltrans has advised staff that the City Council must adopt the name "Broadway Auto Row" by Resolution or we are in jeopardy of losing the name on the two highway exit signs. Adoption of this Resolution will allow the existing signs to be retained.

FISCAL IMPACT

There is no fiscal impact to the adoption of the Resolution as Broadway Auto Row is already included on the Caltrans highway signs and Caltrans does not require further City street sign installation.

KEY ISSUES AND IMPACTS

The I-880 exit has a "Broadway Auto Row" sign, but Auto Row does not really begin until West Grand Ave. It is not practical to install Auto Row signs along Broadway through downtown. Caltrans will accept the naming of a very small portion of Broadway in order to maintain the highway exit sign. Therefore, staff proposes to rename just the portion of Broadway under I-880 from 5th St. to 6th St., to Broadway Auto Row. For the Broadway and 580 area, staff proposes to just rename the area under the underpass at I-580 and Broadway. This is acceptable to Caltrans for their purposes.

PROJECT DESCRIPTION

In the latter part of the 1990s, staff embarked upon a capital improvement and marketing campaign to brand the City's cluster of auto dealerships along Broadway. Caltrans installed two highway exit signs (at I-880 and at I-580) that use the moniker, "Broadway Auto Row". More recently, a "Buy Oakland' marketing campaign has highlighted the area. However, past staff efforts never included a Resolution, required by Caltrans, for the name "Broadway Auto Row".

Caltrans is now indicating to staff that the City Council must adopt the name by Resolution or we are in jeopardy of losing the name on the two highway exit signs.

Adopt a Resolution renaming "Broadway" between 5th Street and 6th Street and under I-580 to "Broadway Auto Row".



A RESOLUTION RENAMING "BROADWAY" BETWEEN 5^{TH} STREET AND 6^{TH} STREET AND UNDER I-580 TO "BROADWAY AUTO ROW"

WHEREAS, in the latter part of the 1990s staff embarked upon a capital improvement and marketing campaign to brand the City's cluster of auto dealerships along Broadway; and

WHEREAS, more recently a "Buy Oakland' marketing campaign has highlighted the auto sales area; and

WHEREAS, past efforts never included official codification of the name "Broadway Auto Row" as the street name for this area; and

WHEREAS, Caltrans is indicating that the City Council must adopt the name by Resolution or possibly lose the name on two freeway signs at Broadway and both I-880 and I-580 off ramps; now, therefore, be it

RESOLVED: That the portion of Broadway between 5th Street and 6th Street and under I-580 shall be named "Broadway Auto Row"; and be it further

RESOLVED: That the City Administrator or her designee is hereby authorized to take any appropriate action with respect to the name change consistent with this Resolution and its basic purposes.
