# OAKLAND CITY COUNCIL

RESOLUTION No. 88403 C.M.S.

**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, OR DESIGNEE, TO ACCEPT AND APPROPRIATE GRANT FUNDS IN THE AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000) FROM THE STATE OF CALIFORNIA, OFFICE OF TRAFFIC SAFETY (OTS), FOR THE FISCAL YEAR 2019-2020 SELECTIVE TRAFFIC ENFORCEMENT PROGRAM (STEP), TO BE ADMINISTERED BY THE OAKLAND POLICE DEPARTMENT (OPD); AND AUTHORIZING THE GENERAL PURPOSE SERVICES FUND TO CONTRIBUTE SEVENTY TWO THOUSAND SEVEN HUNDRED FORTY-ONE DOLLARS (\$72,741) TO COVER THE RELATED CENTRAL SERVICES OVERHEAD CHARGES.**

**WHEREAS**, the Selective Traffic Enforcement Program (STEP), from the State of California, Office of Traffic Safety (OTS) is designed to reduce the number of people injured or killed in crashes involving alcohol, speed, red light running, and other primary collision factors through the combined efforts of OTS and local law enforcement agencies; and

**WHEREAS**, grant funds totaling Five Hundred Thousand Dollars (\$500,000) have been awarded by OTS for the Oakland Police Department's (OPD) continued participation in STEP for the current fiscal year; and

**WHEREAS**, the FY2020-21 STEP grant award period of performance is October 1, 2020 through September 30, 2021; and

**WHEREAS**, the City Council previously authorized acceptance of similar OTS STEP grant funds by Resolution No. 87878 C.M.S., dated October 1, 2019, Resolution No. 87363 C.M.S., dated October 2, 2018, Resolution No. 86958 C.M.S., dated November 7, 2017, Resolution No. 86491 C.M.S. dated November 29, 2016, Resolution No. 85274 C.M.S., dated November 18, 2014, Resolution No. 83555 C.M.S., dated September 20, 2011, Resolution No. 81223 C.M.S., dated December 9, 2008, Resolution No. 80578 C.M.S., dated May 15, 2007, and Resolution No. 80130 C.M.S., dated September 19, 2006; and

**WHEREAS**, OTS does not allow STEP grant awards to be used for indirect overhead costs; therefore be it

**RESOLVED:** That the City Council does hereby authorize the City Administrator or designee to accept and appropriate a grant award in the amount of five hundred thousand dollars (\$500,000) from the State of California OTS; and be it

**FURTHER RESOLVED:** That the City Council does hereby authorize all CSO overhead charges associated with this grant in an estimated amount of seventy-two thousand

seven hundred forty one dollars (\$72,741) for Fiscal Year 2020-2021 be offset through a contribution of the General Purpose Fund; and be it

**FURTHER RESOLVED:** That the grant funds shall be maintained in the State of California Grant Fund: 2159, Traffic Enforcement Division Org.: 107510; Traffic Enforcement Program: PS14, in a Project to be determined; and be it

**FURTHER RESOLVED:** That the City Council hereby authorizes the City Administrator or designee to act as an agent to conduct all negotiations and related actions and to sign all applications and agreements that may be necessary for the completion of the aforementioned grant.


