RESOLUTION AUTHORIZING THE ACCEPTANCE OF UP TO FOUR HUNDRED TWENTY-FOUR THOUSAND, TWO HUNDRED FORTY-THREE DOLLARS AND THIRTY-THREE CENTS (\$424,243.33) IN CALIFORNIA OFFICE OF HOMELAND SECURITY [OHS FY 03 STATE HOMELAND SECURITY GRANT PROGRAM – Part II (SHSGP 03 PART II)] CRITICAL INFRASTRUCTURE PROTECTION (CIP) GRANT FUNDS FOR REIMBURSEMENT OF OVERTIME COSTS INCURRED BY THE OAKLAND POLICE DEPARTMENT DURING THE HOSTILITIES WITH IRAQ, FOR THE PERIOD MARCH 17, 2003 TO APRIL 16, 2003

WHEREAS, the President of the United States recently signed into law the Wartime Supplemental Appropriations Act of 2003, which provides \$16 million to the State of California to reimburse agencies responsible for securing critical infrastructure sites during the hostilities with Iraq; and

WHEREAS, the California Office of Homeland Security (OHS) FY 03 State Homeland Security Grant Program Part II, Critical Infrastructure Protection (CIP) Grant is providing financial assistance to cities for costs associated with increased security measures at critical infrastructure sites, for the period March 17, 2003 to April 16, 2003; and

WHEREAS, the City of Oakland Police Department incurred \$424,243.33 in eligible overtime costs during the grant period in the General Fund; now therefore be it;

RESOLVED: That the City Council hereby authorizes the City Manager to accept California Office of Homeland Security Critical Infrastructure Protection Grant funds and credit receipt to the Police Department to reduce the impact of overtime costs incurred by Police Department staff providing increased security measures at critical infrastructure sites during the period March 17, 2003 to April 16, 2003; and be it

FURTHER RESOLVED: That said funds shall be appropriated to the Fiscal Year 2002-2003 budget in Fund 1010, Org. No. 104111, Account 46229, Program P814.
