RESOLUTION AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE A CONTRACT FOR AN AMOUNT NOT TO EXCEED \$160,000 WITH CHS CONSULTING GROUP FOR PROFESSIONAL SERVICES TO PREPARE DESIGN AND ENGINEERING SERVICES FOR THE "REVIVE CHINATOWN" COMMUNITY TRANSPORTATION PLAN

WHEREAS, the Oakland Pedestrian Safety Project (OPSP in CEDA) in its research for the creation of the Pedestrian Master Plan identified pedestrian safety issues in Oakland's Chinatown; and

WHEREAS, Oakland's Chinatown has both the highest pedestrian volume of Oakland neighborhoods as well as a high number of pedestrian collisions; and

WHEREAS, the OPSP applied for and was awarded an Environmental Justice Planning Grant from the California Department of Transportation (Caltrans) of a total of \$225,000 to assist in improving pedestrian and multi-modal issues in Chinatown deposited in Fund 2140 Project G226910; and

WHEREAS, the Caltrans grant requires a matching 10% of the total of \$250,000 (\$25,000) from the City, designated from the Redevelopment Agency and deposited in Fund 9526 Project P123810; and

WHEREAS, the grant stipulates design and engineering tasks utilizing grant funds capped at \$160,000 which includes \$155,200 for CHS Consulting Group and an additional \$4800 for contract compliance; and

WHEREAS, the OPSP prepared and distributed a Request for Qualifications to design and engineering consultants, seeking a team to prepare streetscape drawings and transportation recommendations for Transportation Planning Grant; and

WHEREAS, CEDA received four responses to the Request for Qualifications and a Selection Committee interviewed all four respondents; and

WHEREAS, the Selection Committee recommended CHS Consulting Group, a local small business enterprise, and its associated team to prepare the streetscape design and transportation recommendations; and

WHEREAS, the services provided pursuant to the agreement authorized hereunder are of a professional, scientific or technical nature and are temporary in nature; and

WHEREAS, this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

RESOLVED: That the City Manager is hereby authorized to negotiate and execute a contract for an amount not to exceed \$155,200 with CHS Consulting Group and an additional \$4800 for contract compliance to prepare streetscape drawings and transportation recommendations for Transportation Planning Grant; and be it

FURTHER RESOLVED: That the City Manager or his designee is hereby authorized to extend, amend (except as to increase compensation), and take whatever action is necessary with respect to this contract consistent with this Resolution and its basic purpose; and be it

FURTHER RESOLVED: That the contract shall be reviewed and approved by the City Attorney for form and legality prior to execution, and a copy shall be placed on file with the City Clerk.
