RESOLUTION NO. _____ C.M.S.

A RESOLUTION TO AUTHORIZE THE CITY ADMINISTRATOR, OR HIS DESIGNEE, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE PACIFIC COAST COLLABORATIVE IN THE AMOUNT OF TWENTY-FIVE THOUSAND DOLLARS (\$25,000) PER YEAR FOR THREE YEARS IN A TOTAL AMOUNT NOT TO EXCEED SEVENTY-FIVE THOUSAND DOLLARS (\$75,000) BEGINNING IN FISCAL YEAR 2020-2021 AND ENDING IN FISCAL YEAR 2022-2023 TO PARTICIPATE IN THE WEST COAST REGIONAL FOOD WASTE REDUCTION PROJECT

WHEREAS, in December 2012, the City Council approved Resolution No. 84126 C.M.S. adopting the Energy and Climate Action Plan identifying waste reduction as an action to reduce greenhouse gas (GHG) emissions in Oakland; and

WHEREAS, in September 2016, Governor Brown signed into law the Short-Lived Climate Pollutants (SLCP): Organic Waste Methane Emissions Reduction Act known as SB 1383 (Lara, Chapter 395, Statutes of 2016); and

WHEREAS, SB 1383 sets a statewide goal of 75 percent reduction of organic waste disposal from the 2014 level by 2025, and requires that the maximum amount of edible food that is currently disposed of be recovered for human consumption; and

WHEREAS, food generators such as supermarkets and large grocery stores, food services providers, food distributors and wholesale food vendors must comply with the food recovery requirement beginning January 1, 2022; and

WHEREAS, Oakland is required to increase access to food recovery organizations by food generating businesses; and

WHEREAS, the Pacific Coast Collaborative (PCC) is a strategic alliance of jurisdictions seeking to implement a West Coast Regional Food Waste Reduction Project (Project) to curb GHG emissions from commercial food generating businesses by reducing food surplus and ensuring unsold food is donated; and

WHEREAS, the Project, by providing technical support and best practices to said commercial food generating businesses to voluntarily reduce food waste, presents an opportunity to leverage regional resources to lessen or eliminate approximately 100,000

metric tons of carbon dioxide equivalent (MTCO_{2e}) of greenhouse gas emissions attributed to Oakland annually; and

WHEREAS, City staff recommends participating in the Project by entering into a memorandum of understanding with the PCC and contributing \$25,000 per year for three years to a trust established for the purpose of funding the Project; and

WHEREAS, sufficient funding is available in the budget of the Environmental Services: Recycling Solid Waste Organization (30682); now, therefore, be it

RESOLVED: That the City Administrator or his designee is hereby authorized to execute a memorandum of understanding with the Pacific Coast Collaborative and to contribute funds to a trust so established, for the implementation of the Project; and be it

FURTHER RESOLVED: That expenditures for the Project shall not exceed twenty-five thousand dollars (\$25,000) per fiscal year beginning FY 2020-2021 and ending FY 2022-2023 for three years in a total amount not to exceed seventy-five thousand dollars (\$75,000) and funding is available in the Recycling Program Fund (1710); Environmental Services: Recycling Solid Waste Org (30682); Misc. Contract Account (54919); Recycling and Solid Waste Program (SC17); Non-Residential Recycling Project (1001673); and be it

FURTHER RESOLVED: That a copy of this resolution shall be filed with the City Clerk.
