

**ADOPT A RESOLUTION COMMEMORATING THE 55TH ANNIVERSARY OF

WHEREAS, As members of the Progressive National Baptist Convention, the members of Bethany Baptist Church worked closely with the Reverend Dr. Martin Luther King Jr. to rally nonviolently for equal rights as part of the Civil Rights movement; and

WHEREAS, Bethany Baptist Church has worked nationally and globally in assisting those who have been touched by national disasters; and

WHEREAS, Under the pastorship and spiritual leadership of Reverend Johnny M. Leggett, Bethany Baptist Church's theme for the 55th year anniversary is: Persevering with Purpose; and

WHEREAS, Bethany Baptist Church as a revered Oakland institution consistently dedicates itself to community service and to uniting Oakland's community at large; now therefore be it,


