**RESOLUTION REJECTING ALL BIDS AND AWARDING A CONTRACT IN THE OPEN MARKET TO MEDECO SECURITY LOCKS FOR THE PURCHASE OF LOCKING PARKING METER DOORS AND NEXGEN KEYS IN AN ANNUAL AMOUNT OF \$250,000.00 PER YEAR FOR A THREE-YEAR TERM, JANUARY 1, 2021 TO DECEMBER 31, 2023; AND AUTHORIZING THE CITY ADMINISTRATOR TO EXTEND THE AGREEMENT FOR TWO ADDITIONAL ONE-YEAR TERMS FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED \$1,250,000.00**

**WHEREAS**, on October 11, 2019 in accordance with Oakland Municipal Code (OMC) 2.04.050 the City advertised and conducted competitive bidding via Specification No. 20-550-00/ Request For Quotation 167505 for the purchase of locking parking meter door assemblies; and

**WHEREAS**, The City received only one bid from Integrated Parking Management Solutions (IPS) and the sample submitted did not fit current City parking meters, leading it to not meet the form, fit, and function requirement for a valid bid; and

**WHEREAS**, OMC section 2.04.050.J authorizes the City Administrator to proceed to purchase the locking parking meter doors in the open market when no valid bids are received after advertising and competitive bidding; and

**WHEREAS**, this contract will allow for the replacement of vandalized or broken parking meter doors and the installation of doors on newly installed meters ; and

**WHEREAS**, there are no local suppliers or contractors who could provide the locking parking meter door assemblies; and

**WHEREAS**, the proposed contract exceeds the City Administrator's limits for the purchase of supplies, services or combination thereof, of \$250,000 under OMC section 2.04.030.A.1.a, and therefore requires Council approval of the award of the purchase contract to Medeco Security Locks; now, therefore, be it

**RESOLVED:** That the Council hereby rejects all bids and awards a contract in the open market to Medeco Security Locks for the purchase of locking parking meter door assemblies and Nexgen keys, in an amount of two hundred fifty thousand dollars (\$250,000.00) per year for a three (3) year term, January 1, 2021 to December 31, 2023, pending the availability of funds; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to amend the contract to extend it for two additional one-year terms for an amount of two hundred fifty thousand dollars (\$250,000.00) per year, pending the availability of funds, for a total not-to-exceed contract amount of one million two hundred fifty thousand dollars (\$1,250,000.00) for a potential term of five (5) years.
